Election Integrity and Equity Resolution

- I. WHEREAS ASLMU Senate, in keeping with the Jesuit and Marymount traditions, empowers the voice of all students within the upcoming ASLMU Elections in order to promote a vibrant and diverse campus life; Senate would like to ensure the integrity of the Election by outlining that elected, hired, appointed, or volunteer members of ASLMU may not use their position as a form of threat, leverage, or enticement for other members of ASLMU.
- II. WHEREAS ASLMU Senate devotes ourselves to being people for and with others, we stand in solidarity with all students, both those participating and those voting. Those in ASLMU may not promise positions to other ASLMU members on the condition of campaign assistance or other forms of coercion that give those in ASLMU an unfair advantage over others running.
- III. WHEREAS ASLMU Senate encourages freedom of expression and all viewpoints, we do not support any activity that will interfere or provide unfair advantages to those already elected, appointed, or hired. The President, Vice President, unless seeking reelection, and ASLMU Advisor are to hold current ASLMU members accountable for any Elections fraud or antics deemed a violation of the mission of ASLMU or the university at large, and refer them to the Judiciary Process, as per the ASLMU Bylaws.
- IV. WHEREAS ASLMU Senators were elected to represent the undergraduate student body of LMU and will continue to use their positions to represent those within their constituency, ensuring that the result of the Elections reflect this as well, without interference.
- V. WHEREAS the Elections Chair and Elections Committee are already working, separate of ASLMU, to ensure the integrity of the Election. No elected, hired, or appointed of ASLMU sit on the committee, ensuring there is no bias or advantage given to those looking to be elected.

THEREFORE BE IT RESOLVED that ASLMU Senate looks forward to the upcoming ASLMU Election season and will work to ensure the continued integrity and equity of this Election. With the goal of safeguarding all the values associated with and representative of the LMU Mission Statement and Lion's Code and bettering the LMU Community with the Election of those best fitted for the position.
